

# **MEMO REMINDERS**



#### BEST PRACTICES FOR STREAMLINING APPLICATIONS FOR YEAR-ROUND PROGRAM OPERATIONS

"FNS is pleased to announce the release of CACFP 08-2023, SFSP 10-2023, "Best Practices for Streamlining Applications for Year-Round Program Operations." This memorandum and attachment provides guidance to assist State agencies in streamlining the application process for experienced program operators that participate in both the Summer Food Service Program (SFSP) and the at-risk afterschool component of the Child and Adult Care Food Program (CACFP). FNS encourages community organizations that offer CACFP afterschool meals during the school year to transition to SFSP to serve the same group of children during the summer months, but hopes this memorandum helps simplify paperwork responsibilities by minimizing duplication and reducing administrative burden. This guidance also recommends options for streamlining the application process for experienced program operators in States where the same administering agency is responsible for both programs."


